31 st December 2017	<p>PUBLICATION OF THE FINAL MOUNTAIN BIKE RANKINGS</p> <p>For the UCI endurance team ranking, the riders individual UCI points in the UCI individual ranking of 31 December calculated as per article 4.7.006 will be used to determine the UCI elite MTB endurance team status.</p> <p>For the UCI gravity team ranking, the final individual world cup standings of the previous year and the world championships results by attributing points as per the table in article 4.9.002 will be used to determine the UCI elite MTB gravity team status.</p>
15 th January 2018	<p>TEAM REGISTRATION DEADLINE AND PAYMENT</p> <p>Application for UCI MTB Teams is as follows:</p> <p>UCI MTB Endurance Team can apply for a registration only if the team is ranked with a total point of 75 in the UCI endurance team ranking: the riders individual UCI points in the UCI individual ranking of 31 December calculated as per article 4.7.006.</p> <p>UCI MTB Gravity team can apply for a registration only if the team is ranked with 1 point in the gravity team ranking: the final individual world cup standings of the previous year and the world championships results by attributing points as per the table in article 4.7.006.</p> <p>All teams must submit their application and pay the standard fee of EUR 2'500.- (for further details regarding the fees, please refer to the UCI MTB Financial Obligations).</p> <p>Payment should mention the exact name of the team it is related to.</p>
9 th February 2018	<p>PUBLICATION OF THE UCI MTB TEAMS (ELITE AND STANDARD TEAMS).</p> <p>UCI will inform the UCI ELITE MTB Teams by e-mail.</p> <p>Publication of the UCI MTB Team Ranking (Endurance and Gravity as per article 4.9.002).</p>
16 th February 2018	<p>UCI ELITE MTB TEAMS CONFIRMATION</p> <p>All teams have to confirm their status taking into account the obligation and complete the table with the exact dimensions of the space required for each UCI MTB World Cup round.</p> <p>Payment deadline for the UCI ELITE MTB TEAMS of the remaining fee of EUR 1'000.-.</p>

2 Registration form and requested documents

Documents to return	More information
Registration form	Fill in the registration form (excel file) completely electronically.
Letter of approval	Letter of approval from the national federation of the country where the head office or the domicile of the paying agent is located.
Copy of each rider's contract	Copy of each rider's signed and dated contract in accordance with article 4.10.018, this document will be treated as strictly confidential. As per UCI MTB Regulations – article 4.10.024, the model contract between a rider and a UCI MTB Team should be used. In attachment, you will find a “Word” document of the UCI standard contract. Contract for junior riders <u>must be signed also</u> by the legal representative of the rider.
Colour graphic design	Colour graphic design of the teams jersey with the logos of the sponsors. This is not applicable for UCI Gravity Teams.

In addition, we also remind you that:

- **a rider cannot be considered as a team manager or staff member of a UCI MTB Team.**
- **the general email address of the team should not be the same as a rider's email.**
- **a team must imperatively have a team manager to be registered.**

The number of riders per team is regulated as follows:

- For a Cross-country team: min. 3 riders and max. 10 riders
- For a Gravity team: min. 2 riders and max. 10 riders
- For a Cross-country/Gravity team: min. 3 riders and max. 10 riders
