

**ATHLETES DECLARATION IN RELATION WITH THE WEARING OF CAMERAS MOUNTED ON THE BICYCLE AND/OR ONTO THE VISORS/PEAKS OF THE HELMET DURING FINALS/ TRAINING SESSIONS RELATED TO MOUNTAIN BIKE AND BMX DISCIPLINES ORGANIZED UNDER THE AEGIS OF THE UNION CYCLISTE INTERNATIONALE (UCI)**

I, the undersigned, understanding that my signature to this declaration does not limit the obligation of the organizer to prepare and maintain competitions courses in accordance with UCI Rules and UCI safety standards then in effect:

Do hereby agree to wear a camera on the bicycle and/or onto the visors/peaks of the helmet during finals/ training sessions of the 2018 Mercedes-Benz UCI MTB World Cup organized under the aegis of the UCI and authorize the company Red Bull Media House to distribute footages taken by it in accordance with the contract which binds it with the UCI. This footage can include moving images or still pictures.

Except for training sessions, I agree that I will not be the owner of all materials developed or created by the Broadcaster, including ownership of all intellectual property rights in such materials. After the finals, I agree to hand over the footage to the UCI or other third person authorized by the UCI.

I acknowledge that I am allowed to publish my GoPro qualifying run and/or my final GoPro run on my athlete or team social networks on the following conditions:

*GoPro qualifying run:*

As a selected athlete, I am allowed to publish my qualifying run on my athlete or team social networks upon reception of the clip from the GoPro ambassador. The clip will be provided directly by the GoPro ambassador and the following guidelines must be applied: (i) the Red Bull TV Bumper has to be included at the end of the clip and (ii) my post must include a link to the Red Bull TV live broadcast (detailed in team videographer guidelines).

*GoPro finals run:*

As a selected athlete, I am allowed to publish my final run on my athlete or team social networks 24 hours after the end of the race and upon reception of the clip from the GoPro ambassador. The clip will be provided directly by the GoPro ambassador and the following guidelines must be applied: (i) the Red Bull TV Bumper has to be included at the end of the clip and (ii) the post must include a link to the "video on demand" Red Bull TV live replay broadcast (detailed in team videographer guidelines).

I am fully aware and conscious of the potential risks that might arise with the use of such equipment and accept them.

To the extent permitted by the applicable law, I release UCI, my National Federation, the organizers, the sponsors, and their respective members, directors, officers, employees, volunteers, contractors and agents from any liability linked to the utilisation of the camera on the bicycle and/or onto the visors/peaks of the helmet. This concerns in particular cases of accidents, injury, and damage to personal property or third-party property linked to the utilisation of a camera on the bicycle and/or onto the visors/peaks of the helmet during finals/ training sessions of the 2018 Mercedes-Benz UCI MTB World Cup.

I acknowledge and agree that I will not receive any cash payment or other financial compensation for the rights and permissions granted by me under this Agreement.

I agree that all terms of this Agreement are confidential and may not be disclosed to any third party except (i) with the consent of that other party or (ii) if such information has come into the public domain otherwise than breach by that party of this clause or (iii) as required by law or other applicable regulations. The duties of the parties in this clause shall survive the expiration or earlier termination of this Agreement.

This Declaration is governed and constituted according to Swiss law and, to the extent permitted by applicable law, shall also be binding on my family, relatives, heirs, successors, beneficiaries or anyone who might pursue any legal action in connection with any event related to the above.

In consenting this Agreement, I have not relied upon any representations made by the UCI or its representatives and I have relied solely upon my own judgment or the advice of my own advisors.

I am fully aware and conscious that the use of onboard cameras is subject to other requirements from the UCI and therefore that the signature of this Agreement does not mean that I will be automatically allowed to wear onboard cameras.

I have read and understood the terms of this Athlete's Declaration, which is effective as of the date included below.
