

Mercedes-Benz UCI Mountain Bike World Cup

Depending on the risk classification of the country of origin or the last place of residence in the last 10 days before entry into Germany, different regulations apply.

Before entering Germany, please find out whether your country of origin/last place of residence within the last 10 days before entering Germany is classified as a risk, high incidence or virus variant area.

The following regulations apply depending on the risk classification

a) Entring from a non risk area, risk area, high incidence area or virus variant area

- All persons entering the Federal Republic of Germany by plane are required to present their carrier with a negative test result before departure.
- The test result must be issued in German, English or French and must be carried with you.
- The result must not be older than 48 hours bevor the entry.

b) Entring from a risk area

1. Step – letter of invitation

- A letter of invitation from the organiser is required for entry into Germany.

2. Step - digital registration

- **Before entering Germany**, you must carry out a **digital registration on entry**.
- Under the following link you can fill out the registration https://www.einreiseanmeldung.de/#/
- After filling in you will receive a PDF file as confirmation. This document must be carried with you throughout your stay.





3. Step - Obligation to undergo testing and provide proof of negative testresult

- Within a maximum of 48 hours after entering the country, you must have a negative corona test result.
- The test result must be carried with you throughout your stay.

4. Step - Obligation of quarantine

- Entrants who are accredited by the respective organising committee for the purpose of preparing, participating in, conducting or following up on international sporting events or who are invited by a federal sports federation to participate in training and course measures do not have to go into quarantine.

c) Entring from a high risk area

4. Step - Obligation of quarantine

d) Entring from a virus variant area

1. Step – letter of invitation

- A letter of invitation from the organiser is required for entry into Germany.

2. Step - digital registration

- **Before entering Germany**, you must carry out a **digital registration on entry**.

- After filling in you will receive a PDF file as confirmation. This document must be carried with you throughout your stay.

3. Step - Obligation to undergo testing and provide proof of negative testresult

- Travellers must get tested before starting their journey and present a negative test result to their carrier.
- The test result must be issued in German, English or French and must be carried with you throughout your stay.
- The result must not be older than 48 hours at the time of entry.





4. Step - Obligation of quarantine

- After arrival you must make your way directly to a place of accommodation at your destination and remain isolated there for a period of ten days (home quarantine).
- If typical symptoms of coronavirus appear within 10 days after entry, the competent authority must be informed immediately.
