MESSAGE FROM THE PRESIDENT



Dear members,

First of all, I would like to reiterate my best wishes for 2025. The first few weeks of the year are already behind us, and we have a great deal to look forward to in the weeks and months to come.

Once again, our sport will be breaking new ground. After the inaugural UCI Cycling World Championships - in Glasgow and across Scotland - in 2023, and the first combined UCI Road and Para-cycling Road World Championships – in Zurich, Switzerland – in 2024, this year will see the first edition of the UCI Road World Championships to be held on the African continent. All eyes will be on Kigali from 21 to 28 September. and I look forward to seeing a great many of our

National Federations in the Rwandan capital as we make cycling history together. Look out for updates about the event in upcoming editions of the newsletter. We are again organising Chef de Mission meetings to ensure all Federations have the latest information and can bring up any queries they may have as they prepare for these UCI Road World Championships. The first of these will take place on 26 February and you will find details in the sports section of this newsletter.

The road season is already underway, and I had the privilege of attending the first event of the 2025 UCI Women's WorldTour, the Santos Tour Down Under, which took place in Australia from 17 to 19 January. This was followed by the men's stage race of the same name which has finished few days ago. Both were excellent season openers for our leading series of women's and men's professional road racing.

While in Australia, I also attended the elective Congress of the Oceania Continental Confederation (OCC) in Adelaide on the 16 January. This was a fantastic occasion to meet with representatives of the continent's National Federations and take part in discussions about the development of our sport across Oceania. Congratulations to Tony Mitchell, who embarks on another four-year term at the head of the OCC.

As always, it is the discipline of cyclo-cross that takes centre stage in January. The 2024-2025 UCI Cyclo-cross World Cup has just come to an end after a magnificent two months of almost weekly competitions. This has set the tone for the 2025 UCI Cyclo-cross World Championships, which will take place from 31 January to 2 February in Liévin, marking this event's return to France for the first time in 20 years. On this occasion we will also be holding the first UCI Management Committee meeting of the year in Arras. I look forward to seeing many of you this weekend!

Finally, I would like to congratulate Mr. Jorge Daniel Espinoza Rosales on his election as President of the Chilean Cycling Federation, Mr. Avni Nuha on his re-election as President of the Kosovo Cycling Federation, Mr. Ayman Aly Hassan Soliman on his election as President of the Egyptian Cycling Federation and Mr. André Tchicaya-Loemba on his re-election as President of the Congolese Cycling Federation. On behalf of the UCI, I thank them for their continued efforts in promoting cycling and wish them every success and satisfaction in their respective roles.

Effective changes to the regulations

On 18 December 2024, the UCI Management Committee members were asked to review and approve various amendments and special provisions to the UCI Regulations, following suggestions from SafeR (the structure dedicated to safety in men's and women's road cycling) and the Professional Cycling Council (PPC). A special edition of the [UCI](#)

[Newsletter](#) was distributed, providing detailed information on these changes and provisions.

Prize money platform

During the month of February, the UCI WorldTour, UCI Women's WorldTour, UCI ProSeries and Class 1 event organisers must update (or create if needed) their account on the [centralised prize money management platform](#), so that prize money can be paid in accordance with the UCI Regulations (art. 1.2.071).

During February and March, UCI WorldTeams, UCI Women's WorldTeams, UCI ProTeams, UCI Women's ProTeams, UCI Continental Teams, UCI Women's Continental Teams, National Teams, UCI Cyclo-cross Professional Teams and their riders must also update (or create if needed) their account on the [centralised prize money management platform](#), so that prize money can be paid in accordance with the UCI Regulations (art. 1.2.071). For structure with several teams (e.g. professional team and development team, we remind them that each team has a dedicated account, so please ensure that they are all up to date.

Any prize money due to teams not included in the above list (i.e.: club teams, UCI Cyclo-cross Teams, regional teams) will be transferred to the National Federation of the team concerned, that will then receive the prize money.

2025 UCI Safety Manager Courses

This is a reminder for the race organisers who have registered their Safety Managers for the 2025 online course to obtain their mandatory certification.

The platform is now open to proceed with the payment. Please ensure the payment is completed promptly to secure access to the course. The academic content will become available on February 17, 2025.

Registration of UCI Women's Continental Teams and UCI Continental Teams for the 2025 season

A total of 38 UCI Women's Continental Teams and 183 UCI Continental Teams from the five continents have submitted a registration request for the 2025 season. The names of all the teams with a compliant file have now been published on the [UCI website](#).

We ask National Federations registering teams to check that all tasks have been approved by the UCI on the UCI DataRide – Teams platform. If this is not the case, please ensure that the required corrections are made so that the process can continue and that the names of the teams that have not yet been published can be published as soon as possible.

We would like to remind all parties that they should consult the UCI website before each event to make the necessary verifications. We therefore invite teams and National Federations to ensure that all information relating to teams and their members has been entered correctly on the UCI website and to send an email to road@uci.ch if there is any issue. Only riders and Sport Directors whose names are correctly published on the UCI website will be permitted to participate in events.

REMINDER : Participation of UCI Continental Teams and UCI Cyclo-cross Professional Teams in UCI ProSeries events

We remind you that UCI Continental Teams and UCI Cyclo-cross Professional Teams can only be invited and permitted to participate in UCI ProSeries events if they are registered in the reinforced anti-doping programme. This registration

was made upon reception of the payment of an additional anti-doping contribution and submission of the online form via the dedicated link by 31 December 2024 (see p.29 of the "2025 UCI Instructions for Registration").

Any team that wishes to participate in UCI ProSeries events but did not proceed with the payment within the deadline will not be authorised to participate in these events during the 2025 season. The list of teams authorised to participate in UCI ProSeries events is available on the [UCI website](#).

UCI ProSeries event organisers can only invite the UCI Continental Teams and UCI Cyclo-cross Professional Teams featuring on this published list.

Participation rules (article 2.2.001 of the UCI Regulations)

As per article 2.2.001 of the UCI Regulations, "Riders belonging to a team registered with the UCI with the same paying agent or main partner may not compete in the same race except in the case of an individual event." Similarly, all affiliated club teams with the same paying agent, team representative or main sponsor as a UCI Team must be declared to the relevant National Federation. We invite all National Federations that have not yet informed the UCI to do so as soon as possible by writing to road@uci.ch and to immediately signal any change occurring during the year.

The list of teams concerned by the provisions of article 2.2.001 of the UCI Regulations for the 2025 season is available on the [UCI website](#).

Mandatory invitations to road races (art. 2.1.007bis, 2.14.020, 2.14.021, 2.14.038, and 2.14.051 of the UCI Regulations)

The UCI Sports Department has published the list of mandatory invitations extended to teams for road events. This is available in the UCI Regulations section of the [UCI website](#).

As per article 2.1.007bis of the UCI Regulations, these provisions concern the UCI WorldTour first and foremost, with UCI ProTeams LOTTO and ISRAEL – PREMIER TECH receiving a mandatory invitation to all the events on the circuit and UNO-X MOBILITY being invited to the one-day races on the UCI WorldTour.

Regarding the UCI Women's WorldTour, in addition to the UCI Women's WorldTeams registered for the 2025 season, EF EDUCATION - OATLY and VOLKERWESSELS CYCLING TEAM, as the two best UCI Women's Continental Teams of the final 2024 UCI World Ranking, must be invited to all UCI Women's WorldTour events by their organisers.

As a reminder, these teams must confirm their participation to the respective organisers at the latest 70 days before the event. Failing this, the concerned team will lose its automatic invitation.

Regarding the UCI Continental Circuits events (ME and MU):

- Organisers of Class 2 events in the UCI Europe Tour, as well as organisers of Class 1 and Class 2 events in the UCI America Tour, UCI Asia Tour and UCI Oceania Tour must invite the top three UCI Continental Teams of the final 2024 classification by team for the relevant continental circuit of the event;
- Organisers of Class 2 events in the UCI Africa Tour must invite the top three national teams of the final 2024 UCI Africa Tour classification by nation.

The teams as well as their contact information are listed in the "Mandatory Road Race Test Invitations List" published on the [UCI website](#).

Finally, regarding the UCI Nations Cups (Under 23, Men Junior and Women Junior), the organisers must also send an invitation to the teams or nations in the document as per the provisions of articles 2.14.020, 2.14.021, 2.14.038, and 2.14.051).

2025 licences

In order to make the rider and staff confirmation process easier at the start of the first races of the year, National Federations are requested to ensure, as soon as possible, that the status of all their licensees registered in UCI Teams, are updated on the UCI DataRide platform for the 2025 season.

2025 UCI Road World Championships

The 2025 UCI Road World Championships will take place from 21 to 28 September in Kigali, Rwanda. More information about the event can be found on the [UCI website](#).

UCI world records

Following the UCI Regulations amendments in force since 1st January 2025, distances for Women Elite and Women Junior world records for track have been updated (art. 3.5.001).

We remind you that a record set during a competition shall only be confirmed if a UCI International Commissaire has been officiating at the race as a member of the Commissaires' Panel (art. 3.5.014) and for the world record to be validated, the rider in question must undergo a doping control immediately following the end of the race (art. 3.5.018). All world record documents must then be submitted to the UCI.

2024 UCI Urban Cycling World Championships - Abu Dhabi

Five UCI Trials World Champions were crowned at the 2024 edition of the UCI Urban Cycling World Championships last December. Jack Carthy (GBR), Alejandro Montalvo (ESP) and Alba Riera (ESP) were victorious in the Elite Men 26", Men 20" and Women categories respectively.

Travis Asenjo (ESP) and Roman Salaun (FRA) were awarded the titles in the Junior 20" and 26" competitions. Meanwhile, Spain emerged victorious in the mixed team trials – their sixth consecutive victory - followed by France and Germany.

Artistic cycling – submission of new artistic cycling figures

The UCI has put in place a new procedure to submit proposals for new artistic cycling figures to be added to the UCI Regulations. As of now, all new proposals should be submitted using the following form: [Monday.com – Submission form - Artistic Cycling figures](#).

Please note that submitting a figure through the form does not guarantee that the figure will be added to the UCI Regulations. All submitted figures will be reviewed by the UCI Indoor Cycling Commission and the Artistic Cycling working group and will be considered for future amendments to the UCI Regulations.

COMMISSAIRES

Commissaires training module - yellow cards

Starting in 2025, Commissaires can issue yellow cards in accordance with Article 2.12.007 in situations where behaviour poses a potential safety risk.

Yellow cards apply to the following event classes in the road discipline only:

- UCI WorldTour and UCI Women's WorldTour
- UCI ProSeries (Men and Women)
- Olympic Games, UCI Road World Championships, and Continental Championships (Elite and Under-23 categories).

To ensure consistent application of UCI Regulations by Commissaires, the UCI has developed an online training module. As of now, all UCI Road International Commissaires have successfully completed this training module.

Additionally, National Federations are encouraged to invite their Road National and Elite National Commissaires, particularly those officiating at the specified event classes this season, to complete the online training module and pass the final test to obtain their completion certificates. Commissaires should submit their certificates directly to their National Federation.

Training module overview:

- The self-paced training module is available free of charge on the [UCI iLearn platform](#) in both French and English.
- The module takes approximately 180 minutes to complete and can be divided across multiple sessions.
- Each participant must create an individual account to access the module.
- A minimum score of 16 out of 20 is required to obtain the certificate. Multiple attempts are allowed.

CLEAN CYCLING

2025 List of Prohibited Substances and Methods in force since 1 January 2025





WORLD ANTI-DOPING CODE INTERNATIONAL STANDARD PROHIBITED LIST 2025

The UCI reminds its National Federations that the World Anti-Doping Agency's (WADA) [2025 List of Prohibited Substances and Methods](#) (the Prohibited List) entered into force on 1st January 2025. The Prohibited List designates which substances and methods are prohibited both in and out-of-competition.

The Prohibited List is available on the [Anti-Doping Section](#) of the UCI website.

While, ultimately, the athlete is responsible for knowing what substances and methods are on this list and for the substances present in his or her body, the UCI strongly encourages you to make sure that your members, in particular your athletes and their entourage, are aware of the new Prohibited List.

All major modifications are detailed in the Summary of Major Modifications and Explanatory Notes.

Annual List review process

WADA leads an annual revision process concerning the Prohibited List, beginning with an initial meeting in January and concluding with the publication of the list at the latest on 1st October, so that athletes, their entourage and other stakeholders can acquaint themselves with any modifications.

This is an extensive consultation process that involves [WADA's List Expert Advisory Group](#) gathering information (e.g. the latest scientific and medical research, trends, intelligence gathered from law enforcement and pharmaceutical companies), distributing a draft list to stakeholders and revising it in the light of their comments. The WADA's [Health, Medical and Research Committee](#) revises this document then makes its recommendations to WADA's Executive Committee, which approves the Prohibited List in September.

For a substance or method to be added to the Prohibited List, it must be determined that it meets at least two of the following three criteria:

- It has the potential to enhance or enhances sport performance.
- It represents an actual or potential health risk to the athletes.
- It violates the spirit of sport.
